Can I personalize materials? You bet!

It's simple to add your personal information to most Humana marketing materials.

- 1. Select the item topic you wish to customize
- 2. Select the document type you would like
- Choose "Customize & Download" or "Order"
 - If you want to print them yourself, select Customize & Download
 - If you wish to send materials directly through the MRC, have them printed and sent to you, select "Order"
 - Note: If "Order" is not an option, the piece is only available as a download to your computer
- 4. Complete all required agent information
- 5. Select the image to preview your customizations
- 6. If you are downloading, select "Download" or "Next Step" you're finished!

What if I am ordering personalized materials?

Follow the steps above, then

- 1. Choose the image to preview
- Select the box next to "I approve my customizations"
- 3. Select "Done"
- 4. Once you've approved, select "Next Step"
- 5. Now you can decide where to send materials
 - Once you've added recipients, select "Next Step"
- Ensure all order details are correct and then choose "Add to Cart"
- 7. Purchase your order—you're finished!

You can personalize MRC materials by adding your:

- License number
- Phone number
- Phone number for Spanishspeaking clients
- Hours of operation
- · Web address or email
- Agency logo

Note: You may only customize information as indicated on the form in order to remain compliant with CMS guidelines.

Can I order materials in bulk?

Yes! The MRC contains hundreds of pre-approved marketing materials that can be downloaded or ordered in bulk.

When I can use the MRC materials?

AEP materials are only for use between 10/1 –12/7

× Dissemination or mailing of these materials before October 1 or after December 7 is prohibited by the Centers for Medicare & Medicaid Services (CMS) and the agent's contract with Humana.

Make sure the latest document from the MRC is being used

✓ Download each time you use a document. Required disclaimers change from time to time, so be sure you have the most recent version.
